

## How can I qualify for a Habitat home?

You may be eligible for a Habitat home if you meet the following guidelines: Need, Ability to Pay and Willingness to Partner (Sweat Equity).

**You must be in agreement with all of the statements below:**

**1. I am currently a full-time resident of Angelina County, TX**

**2. I have a housing need.**

- I do not own the home I live in.
- My current housing is inadequate and/or the conditions are substandard.
